According to the study's findings, the characters use three different kinds of politeness techniques: bald on record (15%), positive politeness (22%), and negative politeness (10% percent). Of all the politeness methods employed by the characters in this film, the positive politeness strategy eventually become the most frequently shows. The use of language in this film is adjusted and influenced by the closeness of their relationship as well as by different social contexts.

Leech (1983:23) further extends the idea, defining politeness as a set of actions that not only foster amity but also preserve it. The politeness principle, as articulated by

Leech (1983:81), suggests that individuals should "maximize (other things being equal) the expression of polite beliefs" positively and "minimize (other things being equal) the expression of impolite ideas" negatively.

The dialogues within "A Dog's Journey" unfold with distinct directions, reflecting the varying nuances of different context uses. The characters' choices in employing politeness strategies to convey their messages provide a rich field of analysis. The multifaceted nature of context, as proposed by Mey (1993: 39–40), extends beyond mere setting; it imbues statements with layered meanings. Brown and Levinson (1987: 68–71) offer a framework of four politeness strategies—Bald on Record Strategy, Positive Politeness Strategy, Negative Politeness Strategy, and Off Record Strategy. Within the scope of this study, I will meticulously analyze the deployment of these strategies in tandem with contextual cues in "A Dog's Journey."

This study shares common ground with previous research in terms of exploring politeness strategies and identifying the most frequently used strategies in cinematic contexts. However, a distinguishing feature lies in the meticulous scrutiny of language within its contextual sphere. This nuanced analysis aims to enrich our understanding of the pragmatic underpinnings of cinematic discourse.

The significance of this research reverberates through multiple dimensions. It not only serves as a repository of knowledge for fellow researchers seeking to delve into the pragmatic domain but also opens a gateway to unravel the intricacies of movie scripts. Subsequently, the researcher delves into the film's script, meticulously reading and transcribing its contents. This sequential approach ensures a holistic grasp of the characters' interactions and dialogues. To identify instances of politeness strategies, the researcher employs a discerning eye, highlighting sections where characters employ manners techniques to communicate effectively.

To ensure rigor and validity, a triangulation of sources is undertaken. This involves cross-referencing and comparing data from both the cinematic and scripted formats. This

meticulous process bolsters the integrity of the findings and corroborates the identified politeness strategies.



The results show that the characters in the movie A Dog's Journey use three different sorts of politeness methods, including bald on record strategies, positive politeness strategies, and negative politeness strategies. The study discovered 15 data bald on record strategy (32%), 22 data of positive politeness strategy (47%), and 10 data of Negative Politeness strategy (21%). It could be stated that: "the characters in the movie A Dog's Journey frequently use the positive politeness method while using the negative politeness strategy far less frequently.

This interaction demonstrates how the situational backdrop can significantly influence the selection of communication strategies, highlighting the interplay between context and linguistic behavior.

#### **Positive Politeness Strategy**

In "A Dog's Journey," the positive politeness strategy emerges as a prominent communicative approach, underpinned by the objective of forging connections and fostering solidarity. This strategy becomes particularly salient when characters seek to convey concern, empathy, or camaraderie. The exchange between Ethan and Bailey serves as an exemplar of the positive politeness strategy in action. Ethan's dialogue not only addresses Bailey with familiar and affectionate terms but also showcases his grasp of Bailey's emotional needs. Through this approach, Ethan employs positive politeness to not only maintain their bond but also provide emotional support to Bailey during a time of ailment. This highlights the strategic use of language to create rapport and emotional resonance in the interactions between characters.

## **Negative Politeness Strategy**

The negative politeness strategy, characterized by its indirect and deferential nature, becomes evident when characters aspire to respect the autonomy of others while sidestepping any potential imposition. Trent's invitation to CJ for a double date exemplifies the application of this strategy. Trent employs linguistic politeness markers and constructs his request in a non-intrusive manner, giving CJ the agency to either accept or decline the offer. This serves as a manifestation of Trent's consideration for CJ's autonomy while simultaneously conveying his interest. This strategy underscores the intricacies of interpersonal communication, where

linguistic choices are tailored to maintain social harmony and uphold the autonomy of individuals.

The exploration of politeness strategies within the framework of "A Dog's Journey" uncovers a spectrum of communicative approaches that characters employ in response to the diverse contextual scenarios they encounter. By delving into the dynamics of bald on record, positive politeness, and negative politeness strategies, a deeper understanding emerges of how language is strategically employed to navigate the complex terrain of human interactions. The interplay between context and linguistic choice serves as a lens through which the characters' communication strategies are illuminated, enriching the viewer's comprehension of their interactions within the movie's narrative.
